# **Equality and Diversity Policy**

### 1. Policy Statement

- 1.1 The Council is committed to providing and promoting equal opportunities, eliminating discrimination and celebrating diversity amongst our community.
- 1.2 The purpose of this policy is to provide equality and fairness for all and not to discriminate on grounds of age, disability, gender, marital status, race, ethnic origin, nationality, national origin, sexual orientation, religion or belief. - 2.3 Selection for employment, promotion, training or any other benefits will be on the basis of aptitude and ability. All employees will be helped and encouraged to develop their full potential and the talents and resources of the workforce will be fully utilised to maximise the efficiency of the organisation.

#### 3. Our Commitment

- 3.1 To create an environment in which individual differences and the contributions of all our staff are recognised and valued.
- 3.2 Every employee is entitled to a working environment that promotes dignity and respect to all. No form of intimidation, bullying or harassment will be tolerated.
- 3.3 Training, development and progression opportunities are available to all staff.
- 3.4 Equality in the workplace is good management practice and makes sound business sense.
- 3.5 Provide functions and services that all members of the public to the best of our ability can access.
- 3.6 Make reasonable adjustments when required for staff, councillors and members of the public where required.
- 3.7 We will periodically review all our practices and procedures to ensure fairness.
- 3.8 Breaches of this policy will be regarded as misconduct and could lead to disciplinary proceedings.
- 3.8 The policy will be monitored and reviewed annually to ensure it is compliant with current equal opportunities legislation and follows best practice.
