

**OXFORDSHIRE COUNTY COUNCIL**

- 1. (VARIOUS ROADS - SOUTH OXFORDSHIRE) (MAP BASED) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.\*) ORDER 20\*\***
- 2. (VARIOUS ROADS – VALE OF WHITE HORSE DISTRICT EXCLUDING THE PARISH OF NORTH HINKSEY) (MAP BASED) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.\*) ORDER 20\*\***

**NOTICE** is given that Oxfordshire County Council proposes to make the above orders under the Road Traffic Regulation Act 1984 and all other enabling powers. The Orders further amends the Oxfordshire County Council (Various Roads – South Oxfordshire) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) Order 2021, and the Oxfordshire County Council (Various Roads –Vale of White Horse District excluding the Parish of North Hinksey) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) Order 2022, with the effect of removing Disabled Persons Parking Places (DPPPs) as shown in A below and providing new DPPPs as shown in B.

**A. DPPPs - Removals:**
