OXFORDSHIRE COUNTY COUNCIL (THAME AND VARIOUS PARISHES) (SPEED LIMITS) ORDER 20**

NOTICE is given that Oxfordshire County Council proposes to make the above order under the Road Traffic Regulation Act 1984 and all other enabling powers. The effect of the order - in support of road safety issues - is to introduce a **20mph speed limit** within Thame town, replacing the majority of the 30mph speed limit in the process, leading out to the following points:

- 1. <u>B4445 Aylesbury Road</u> a point 60 metres north of its roundabout junction with Bell Lane & the B4445 North Street.
- 2. <u>B4445 Chinnor Road/Garden City</u> a point 25 metres southeast of its junction with Cotmore Gardens.
- 3. Cheshire Road its junction with the B4012 Howland Road,
- 4. Cromwell Avenue its junction with the A4129 Tythrop Way,
- 5. Fanshawe Road its junction with the B4012,
- 6. Kingsey Road a point 40 metres east of its junction with Kings Road,
- 7. Oxford Road a point 15 metres southwest of its junction with Fish Ponds Lane.
- 8. Pearce Way its junction with the B4012 Howland Road,
- 9. Pickenfield its junction with the B4012 Howland Road,
- 10. Queens Close its junction with the B4445 Aylesbury Road,
- 11. Queens Road its junction with Kingsey Road,
- 12. Roundhead Drive its junction with the A4129 Tythrop Way,
- 13. <u>Thame Park Road</u> a point 15 metres south of its junction with Chowns Close,
- 14. Vane Road its junction with the A4129 Tythrop Way.

Various lengths of 30mph speed limit will be retained within the town - including on the main town approaches of Aylesbury Road, Chinnor Road/Garden City, Kingsey Road, Oxford Road & Thame Park Road - with Officers having taken the current road environment & traffic usage into account. The existing 40mph & 50mph speed limits & those within the parishes of Moreton & Towersey will remain unaffected by these specific proposals.

The Oxfordshire County Council (Thame and Various Parishes) (Speed Limits) Order 2023 will be revoked/replaced as necessary.
